4. Tokenomics

4.1. Token Supply

4.1.1. \$MEIDO token has a maximum total supply of **420,690,000,000 tokens**.

4.2. Token Distribution Details

4.2.1. **Public Allocation 50% (210,345,000,000 tokens):** The Public Allocation will be split into two parts. 1. PinkSale and 2.Public Sale.

4.2.1.1. **PinkSale:** The PinkSale will help to build liquidity for \$MEIDO token. 36.86% or 155,066,334,000 of \$MEIDO will be allocated. Soft Cap 10,000 BUSD, Hard Cap 50,000 BUSD. Pre-sale rate 3,000,000 \$MEIDO for 1BUSD. Min. buy-in 100 BUSD, Max. buy-in 1000 BUSD.

4.2.1.2. **Public Sale:** The public sale will begin a few hours after the PinkSale has ended. 13.14% or 55,278,666,000 \$MEIDO will be allocated.

 - 4.2.2.1. **Character Wallet** (Yumi Fund) 4.0% 16,827,600,000 \$MEIDO tokens.

 - 4.2.2.3. **Marketing Wallet** (Haruka Fund) 2.0% 8,413,800,000 \$MEIDO tokens.
 - 4.2.2.4. **Maid Cafe Wallet** (Mina Fund) 1.0% 4,206,900,000 \$MEIDO tokens.

- 4.2.3. **Burn Wallet 25% (105,172,500,000 tokens)** We've set aside 25% of the tokens to a Burn Wallet, called the "Omurice Wallet", to maintain the token's value and create an ever-evolving economy.
 - 4.2.3.1. 20% of this wallet will be burned every three months post-launch, over the first 15 months of the token's existence, enhancing the token's scarcity and value over time.

This initiative is a step towards democratizing the Meido Kafe ecosystem, allowing our community members to take the helm in steering the token's journey, aligning with the collaborative and inclusive spirit of Maid Cafe culture.
- 7.3.2. Key activities for Q3 include the launch of our Community NFT project, fostering a new dimension of interaction and ownership. We'll also celebrate our first cafe partnership, bringing the Meido Kafe token experience into the physical realm. Additionally, we'll fund our second community project, further solidifying our commitment to community-led initiatives. The quarter will round off with the "Omurice - 2nd serving," the 2nd +21 billion token burn event, reinforcing our dedication to the token's long-term value and community engagement.

In Q4 2024, our focus will be on meticulously observing and responding to our community's growth and feedback, ensuring that Meido Kafe not only sustains but thrives and resonates with our members. We will actively seek and foster collaborations and spin-off projects that align with our community's evolving interests, ensuring that Meido Kafe's journey is both reflective of and contributory to the broader Maid Cafe culture. This approach guarantees that as Maid Cafes reinvent themselves to delight their patrons, Meido Kafe, too, will evolve in harmony with our community's aspirations.
- 7.4.2. In Q4, we'll continue to support our ecosystem with the funding of our 3rd community project, maintaining our commitment to community-driven growth. The "Omurice" protocol will also proceed with its 3rd serving, marking significant milestones in our token burn strategy, with a total of over 21 billion tokens planned for burning.

- 7.4.3. As we move forward, Meido Kafe will continue to embody the warmth, excitement, and community spirit characteristic of Akihabara's Maid Cafes, inviting everyone to be an integral part of our evolving, vibrant world.

8. Meido Kafe Funds - The Details

- 8.1. In line with the Maid Cafe tradition of rewarding loyalty and participation, we're introducing one Founder's Fund and four Meido Kafe Fund that are as delightful as a surprise dessert.
 - 8.1.1. **Founder's Fund (Alko Funds):** This fund is for the devs and project team. This wallet will be locked for 21 days after the token's launch. This wallet has max buy/sell limits, like all other wallets holding \$MEIDO.
 - 8.1.2. **Character Fund (Yumi Fund):** The Yumi Fund is dedicated to funding monthly character launches. The community will develop the initial Meido Kafe team: Haruka, Yumi, Mina, and Saki. The community will vote on these leading characters' designs. The winning verified \$MEIDO token-holding creator of each of the leading four characters will be transferred 1,000,000,000 tokens each from the Yumi Fund as a big thank you from the community for their foundational work. The payout will be to a different verified holder per character. From there, the community will vote on 1 new character per month. Winners of each month's vote will be paid from the Yumi Fund. Once the new character is voted on and accepted by the community of verified Meido Kafe holders, each new verified character creator can receive 0.5% of the Yumi Fund's USD value in Meido Kafe tokens, measured from the day the community agrees upon the project in each funding round, starting from April 31st 2024 until all funds are depleted from Yumi Fund. After the leading characters are designed, an individual creator can win once every 3 months, This rule is to stop dominance by a handful of talented creators, opening up the process to the whole community.
 - 8.1.3. *e.g. If the value in USD of the Yumi Fund on the day of approval is \$250,000 USD, the fund will give \$1,250 USD in value of Meido Kafe tokens to the winning creator.*
 - 8.1.4. As Meido Kafe grows in strength and numbers, the monetary value of the monthly character fee you can earn with the winning character will also increase. NOTE: This fund will be used only after the community

agrees. No vote, no spending. All spending will be transparent and open. This wallet will be locked for 7 days after the token's launch. This is earlier than other wallets to facilitate payouts from the Yumi Fund to the leading character content winners. \$MEIDO tokens in this wallet are not to be sold or burned.

- 8.1.5. **Community Project Fund (Saki Fund):** The Saki Fund is dedicated to funding 4 Community Projects annually, starting from the first "Omurice" burn event on June 30th 2024, and continuing every three months after that until all funds are depleted. These projects should align with our themes of Japanese culture, anime, J-pop, and more. We'll pay for a Godzilla Event if you want to hold it. Do you have an anime project that needs funding? We'll pay for it. Do you want to start a Karaoke business? We'll fund it. Do you want to launch a manga series? We'll pay you to do it. Do you want to launch your own spin-off token? We'll fund it. The only limit to funding is the scale of your idea and getting backing from the Meido Kafe community.
- 8.1.6. Once voted on and accepted by the community of verified Meido Kafe holders, each project can receive up to 1% of the Saki Fund's USD value in Meido Kafe tokens, measured from the day the community agrees upon the project in each funding round.
- 8.1.7. *e.g. If the value in USD of the Saki Fund on the day of approval is \$250,000 USD, the fund will give \$2,500 USD in value of Meido Kafe tokens to the chosen project.*
- 8.1.8. As Meido Kafe grows in strength and numbers, the value of the projects we can fund will also increase. The sky here isn't a limit; it's just another step to Meido Kafe heaven. NOTE: This fund will be used only after the community agrees. No vote, no spending. All spending will be transparent and open. This wallet will be locked for 21 days after the token's launch. \$MEIDO tokens in this wallet are not to be sold or burned.
- 8.1.9. All Fund wallets will be subject to max buy and sell limits in accordance with the tokenomics rules on max. buy and max. sell limits (Read section 9. *\$MEIDO Token Strategy - A Balanced Market* below for details), the same as all wallets holding \$MEIDO. No loopholes. No tricks. No secrets.
- 8.1.10. **Marketing Fund (Haruka Funds):** Funds from the Haruka Fund will be utilised for intelligent, performance-driven marketing, ensuring our token's presence is as noticeable and inviting as a Maid Cafe's colourful storefront. We'll focus on practical strategies that resonate with our community, avoiding unnecessary expenditures. No wasteful spending on expensive, meaningless, non-performing influencers. We will influence the project ourselves. NOTE: This fund will be used only after the community agrees. No vote, no spending. All spending will be transparent and open. This wallet will be locked for 21 days after the token's launch. \$MEIDO tokens in this wallet are not to be sold or burned.

- 8.1.11. **Maid Cafe Fund (Mina Fund):** We're excited to build partnerships worldwide, integrating our token as a tipping and payment method. The long-term vision is to create acceptance across Akihabara, Greater Tokyo, and the rest of the world in that order. Fueled by the Mina Fund, this initiative aims to bridge the virtual with the tangible, bringing our token to life in the heart of Maid Cafe culture. NOTE: This fund will be used only after the community agrees. No vote, no spending. All spending will be transparent and open. This wallet will be locked for 21 days after the token's launch. \$MEIDO tokens in this wallet can be sold, with the community's agreement.

9. \$MEIDO Token Strategy - A Balanced Market

9.1. Anti-whale Mechanism

- 9.1.1. Just as our cafe ensures that each patron enjoys a taste of our signature dishes through carefully portioned servings, we've established initial **anti-whale measures** in the form of max buy and sell limits as a fixed percentage of the total liquidity pool during launch and ramp-up. These limits are hardcoded into the contract, like a cafe's menu, promising a harmonious market where no single entity can overshadow others.
- 9.1.2. **Opening Delights:** Initial Max Buy/Sell Limits
- 9.1.3. From LP launch until \$69,000 USD LP value, the max. buy is 0.5% of LP value and max. sell is 0.2% LP total value.
- 9.1.4. Ensures a balanced and even start, like a carefully portioned appetiser, preventing market dominance by any single entity.
- 9.1.5. **Increasing Portions:** Gradual Limit Increase
- 9.1.6. As the Meido Kafe LP grows in popularity, we will increase the max buy/sell limits dynamically.
- 9.1.7. At greater than \$69,000 USD LP value, and less than \$420,000 USD LP value, the max. buy is 1.0% and max. sell is 0.5% of the LP total value.
- 9.1.8. At greater than \$420,000 LP and less than \$840,000 USD LP value, the max. buy is 1.5% and max. sell is 1.0% of the LP total value.
- 9.1.9. Reflects growing trust and community engagement, similar to offering larger portions of ice cream to returning patrons at a maid cafe.
- 9.1.10. **Grand Feast:** Max Limit Removal
- 9.1.11. When the Meido Kafe LP hits the milestone of over \$840,000, remove the max. buy is 5% and max. sell is 3% of the LP total value.
- 9.1.12. **Community Banquet: Transparency and Engagement**
- 9.1.13. Communicate all phases and changes, ensuring the community is well-informed.

- 9.1.14. Engage with the community to gather feedback, like a cafe listening to its patrons' preferences.
- 9.1.15. Through these thoughtfully designed stages, Meido Kafe creates a trading environment that mirrors the inviting and balanced atmosphere of a Maid Cafe, where every participant enjoys a fair and delightful experience.

9.2. Anti-Bot Mechanism

- 9.2.1. Within the bustling digital streets of Meido Kafe, where the clatter of virtual teacups echoes the community's vibrancy, the Anti-Bot mechanism for \$MEIDO token, "The Doorman", protects the Meido Kafe market's sanctity. The Doorman, is perfectly equipped and programmed to ensure that the marketplace remains a realm of fairness, where every patron's action is genuine, and the spirit of camaraderie thrives unimpeded by the spectre of automation.
- 9.2.2. **Invocation of the Doorman:**
- 9.2.3. Threshold of Activation: When the LP of Meido Kafe dips below certain thresholds, the Doorman springs to life, safeguarding transactions in the Meido Kafe market.
- 9.2.4. Mechanism of Vigilance: The Doorman at Meido Kafe dynamically initiates a timeout between buy and sell transitions from the address. This ensures the market's flow is dictated by thoughtful decisions, not bots' cold, rapid calculations. The Doorman ensures that it activates upon sensing the LP's descent beneath the threshold, ensnaring any bot-driven mischief.
- 9.2.5. **The Doorman's Dynamic Thresholds:**
- 9.2.6. Phase 1: Below \$69,000 liquidity, there is a timeout of 30 seconds between buy and sell transactions from the same address.
- 9.2.7. Phase 2: Below \$420,000 and above \$69,000 liquidity, there is a timeout of 20 seconds between buy and sell transactions from the same address.
- 9.2.8. Phase 3: Below \$840,000 and above \$420,000 liquidity, there is a timeout of 10 seconds between buy and sell transactions from the same address.
- 9.2.9. **The Doorman's Lunch Break:**
- 9.2.10. Lunch Break: As the treasury swells, reaching or surpassing the \$840,000 USD milestone, the Doorman heads for his lunch break, and timeouts of transactions are removed from the Meido Kafe market, restoring the market to its natural rhythm, where transactions flow like tea poured from a pot, smooth and uninterrupted.
- 9.2.11. Automated Harmony: This transition back to normality is seamless, guided by the Doorman's code, which adapts to the market's ebb and flow.
- 9.2.12. **Back to Work:**

- 9.2.13. **Threshold of Renewal:** Should the LP of the Meido Kafe weakened below the \$840,000 mark, the Doorman will stop his lunch break and invoke the anti-bot mechanism once more automatically, reestablishing its vigilant embrace to safeguard the Meido Kafe's integrity.
- 9.2.14. **Eternal Watch:** Unceasing in its duty, the Doorman ensures that whenever the Power of Meido Kafe wanes, the Doorman protects Aiko and her staff from nasty bots, maintaining balance, order and fairness in the Meido Kafe market.

10. Liquidity Pool Receipt Burning

- 10.1. In our commitment to ensuring the long-term value and stability of Meido Kafe, we are adopting a crucial strategic practice within the cryptocurrency ecosystem: the burning of Liquidity Pool receipts. This action is not just a mere procedural step; it's a testament to our dedication to transparency, trust, and the enduring value of our token.
- 10.2. **Why Burn LP Receipts?** Burning LP receipts is akin to a Maid Cafe ensuring that every dish of Omurice served is of the highest quality, reinforcing trust and satisfaction among its patrons. In the context of our token, this process serves multiple significant purposes:
- 10.3. **Enhanced Trust and Security:** By burning LP receipts, we eliminate the possibility of unilaterally accessing the liquidity pool's funds. This action signals to our community and investors that the project is here for the long haul, prioritising the ecosystem's health over short-term gains.
- 10.4. **Token Value Stabilization:** Just as a real-life Maid Cafe carefully manages its menu and ingredients to ensure the best dining experience, burning LP receipts helps manage the token's market dynamics. It reduces the risk of major price manipulations, contributing to a more stable and predictable market for the "Meido Kafe" token.
- 10.5. **Commitment to the Community:** Our community is at the heart of everything we do, much like customers' central role in a Maid Cafe. By burning LP receipts, we reinforce our commitment to our community's interests, ensuring the project's success is shared and celebrated with every member.
- 10.6. **Implementing LP Receipt Burning:** In our roadmap, the burning of LP receipts is a meticulously planned event designed to reinforce the token's integrity and the community's trust. This action will be conducted transparently, with clear communication to all stakeholders, ensuring everyone is informed and can witness this critical step in our project's journey.

11. Renounced Ownership

- 11.1. **Why Renounce Ownership?** Renouncing ownership means that we will transfer the ownership of the token contract to a null address, making it ownerless and immutable. This action declares our confidence in Meido Kafe and its foundational principles. Once ownership is renounced:

- 11.2. **Immutable Contract:** The token's smart contract cannot be altered. This means no changes to trading, no adding of fees, and no token creation, ensuring that the token operates precisely as intended from the outset.
- 11.3. **Decentralisation Commitment:** This mirrors our dedication to decentralisation, reflecting Meido Kafe's inclusive environment where every participant has a voice.
- 11.4. **Protection Against Malfeasance:** It's a proactive measure to prevent potential malicious actions, ensuring that the Meido Kafe token remains secure and as pure and perfect as our leading character, Aiko Hatsubara.
- 11.5. **Synergy with LP Receipt Burning:** Just as burning LP receipts demonstrates our commitment to the token's market stability and community trust, renouncing ownership reinforces our pledge to the Meido Kafe community's long-term interests. Both actions are a testament to our dedication to creating a secure, stable, and community-focused token ecosystem. They reflect our core values of care, dedication, and commitment to quality, drawing parallels with the meticulous attention to detail in Akihabara's best Maid Cafes.

12. Governance

- 12.1. True to the spirit of Maid Cafes, where every guest's wish is honoured, our token governance model empowers holders to have a say in the direction and decisions of the project. Token holders will vote on plans, fund usage, and other crucial aspects, ensuring Meido Kafe reflects its community's desires and dreams. Through these tokenomics, we're not just launching a token; we're setting the stage for a vibrant, interconnected community that grows, decides, and thrives together, much like the bustling and ever-welcoming world of Tokyo's Maid Cafes.

13. Community and Culture

- 13.1. Our community is the soul of the token, infusing it with identity, purpose, and life. We are committed to nurturing this community, planning events, and fostering collaborations that celebrate and strengthen our cultural bonds.
